OFFICER'S INVESTIGATIVE NOTES

Warrant # SRCR153721 - Domestic Assault serious and Criminal Mischief 4th degree - No Bond

On 7-12-17 at about 1610 hours, I, Deputy Temeyer, observed a silver Toyota Sedan bearing IA plate DIM088 northbound on Old Lincoln Hwy near Coit rd. I knew this vehicle to belong to Jason Anthony Hall, who currently had an active arrest warrant and no valid license. I turned around on the vehicle and it took off at a high rate of speed, reaching at least 71 mph on my radar near the lowana curve. I then observed the vehicle pull into the driveway at 18327 Schoolhill ave., which I knew to be Jason's residence, and I initiated a traffic stop. Jason was just exiting the vehicle upon me entering the drive. The warrant was confirmed with dispatch and Jason was placed under arrest and transported to corrections without incident, where he was read a copy of the warrant. He was cited for the speed and no driver license violation. The vehicle was left at his residence. The victim from the original report, Jamie Phillips arrived at the residence while I was there, and showed me an affidavit for dismissal of charges from the warrant. I contacted the county attorney's office and they advised the warrant was still valid, and that her request was only on file at this time. Jamie advised me she did not file a false report, she only wanted the charges dropped.
