On 7-13-2017 I, Deputy Megan Wirt was working in the civil department of the Pottawattamie County Sheriff's Office. At approximately 1530 hours, I was advised by (office staff that there was a person in the jail that needed to be read a warrant. I was then given a copy of an arrest warrant for Daniel Vincent Jr on the charge of Theft 1st (see attached).

I then made contact with the defendant in the booking area of the jail, and confirmed they were the person listed on the warrant. I then read the warrant. I did not read the Miranda Warning, as I did not question them about the incident. Daniel was then turned back over to jail staff.
